

LEGAL TERMS AND CONDITIONS OF THE COMPETITION

MEDITERRANEAN EXPERIENCE BY TM

1. NAME AND PURPOSE

TM Marketing & Sales, S.L.U., with registered address at Plaza Jose Luis Serna, number 1, 03184 Torrevieja (Alicante), Spain, VAT number **B54076096**, hereinafter "**the Company**", is the organiser of the contest entitled **MEDITERRANEAN EXPERIENCE BY TM** (the "Contest"). The Company launches this Contest with the aim of promoting its residential developments along the Spanish Mediterranean coast and raising awareness of its second-home offering among European audiences. The Contest shall be governed by the following terms and conditions:

2. TERRITORIAL AND TEMPORAL SCOPE

There are no territorial restrictions on participation in the Contest.

The Contest will begin upon its publication on the official channels of TM Real Estate Group.

The Contest will **close on 7 June 2026 at 23:59 (Spanish mainland time)**. Entries received after this date and time will not be considered valid.

3. ELIGIBILITY

Only individuals of legal age who meet all the requirements set out in these Terms and Conditions may participate in the Contest.

The following persons are excluded from participation:

- Employees, directors and officers of TM Marketing & Sales, S.L.U. and any other company within the TM group.
 - Persons who do not meet the participation requirements set out in Section 4.
 - Persons who have acted fraudulently or in breach of these Terms and Conditions.

4. HOW TO ENTER

To validly enter the Contest, participants must meet all of the following requirements during the entry period:

6. JUDGING AND WINNER SELECTION

The winner will be selected **after the close of the entry period on 7 June 2026** by a panel of judges appointed by TM Marketing & Sales, S.L.U.

The personal data of participants will be processed by **TM Marketing & Sales, S.L.U.**, as data controller, in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR) and applicable Spanish data protection legislation.

The purpose of processing is the management of Contest entries and, where applicable, the delivery of the prize. Personal data will be deleted once the Contest has been fully managed and any applicable legal retention periods have expired.

13. GOVERNING LAW AND JURISDICTION

These Terms and Conditions are governed by Spanish law. For the resolution of any dispute arising from their interpretation or enforcement, the parties submit, expressly waiving any other jurisdiction that may apply, to the Courts and Tribunals of Alicante (Spain).
